- 341. What is the farthest you have had to bend your standards in order to succeed?

- 343. Think of a time when you anticipated the needs changing in a group you serve.
- 344. Describe the situation and what you did about it.
- 345. How have you personally built consensus within a group?
- 346. Tell us about a goal that you or your organization needed to achieve through teamwork. Tell us how you designed that team.
- 347. What behavior do you use to encourage team members to speak openly?
- 348. Why do people trust you?
- 349. What are some of the factors that you believe constitute a strong team?
- 350. What did you do to support your co-workers in your last job? Please give a specific example of a time when you helped or supported a co-worker.
